The NCC Manufacturer Approval Scheme, which operates across touring caravans, motorhomes and campervans, demonstrates rigorous inspections and testing to ensure regulatory and safety compliance.

Buying a caravan, motorhome or campervan? Don't miss this important detail!

If you've come to the show to buy a new leisure vehicle, there's a small but important detail to look out for – the **NCC Approved Manufacturer badge**.

This badge is your assurance from the NCC – the UK's trade body for the leisure vehicle industry – that the touring caravan, motorhome or campervan you're buying is legally type-approved and compliant with all relevant British and European safety standards.

Every approved manufacturer undergoes regular inspections by expert NCC assessors, who carry out up to 500 checks on a single model. A manufacturer must pass three consecutive formal inspections, followed by ongoing unannounced visits. This process ensures any potential safety critical issues are quickly identified and corrected.

What the checks include:


- · Type Approval confirming compliance with road safety legislation
- Gas and electrical safety making sure installations on models are tested, secure, and fit for purpose
- · Verifying escape routes and ventilation
- Appliance safety to ensure all fitted appliances are suitable and correctly installed

Built to standards you can trust

Approved touring caravans carry the BS EN 1645 badge, while motorhomes and campervans display the BS EN 1646 badge. These inspections confirm the manufacturer produces vehicles that meet strict British and European Standards – designed to keep you, your passengers, and other road users safe.

How to spot an NCC Approved Manufacturer

At the show, NCC Approved Manufacturers are easy to find. Just look for these NCC Approved Manufacturer stickers proudly displayed on the outside of their vehicles.
